15. Multidisciplinary / interdisciplinary

Kharagpur College is a highly esteemed co-educational academic institution offering UG & PG Courses in multifarious subjects. Kharagpur College is a grant-in-aid type of co-educational college affiliated to Vidyasagar University (previously to the University of Calcutta), West Bengal and enjoys UGC recognition under 2(f) and 12(B). It has been accredited by NAAC in cycle 2 as an 'B++' grade College in 2016. The College offers 16 (sixteen) under-graduate Honours courses; 07 (seven) under the Faculty of Arts, 08 (eight) under the Faculty of Science, 01 (one) under the Faculty of Commerce. It runs 03 (three) more UG General course: B.A General in the Morning Shift, B.Sc. General (Pure and Bio. Science) in Day shift and B.Com General in the evening shift. Honours students are to study four generic papers from two subjects other than the honours subject. B.Sc. students of General courses are to study three different subjects and students of BA General course are to choose four different subjects in their entire course. Apart from these, all the students are to study a compulsory ENVS and AECC language in the

first year. Besides this, it offers Computer Science, Sociology and Physical Education as a General Subject. It also offers M.A . courses in Bengali, English and History.

16.Academic bank of credits (ABC):

Kharagpur College follows the regulations of affiliating University. As per the guideline of the affiliating University generation of ABC ID of the students have been initiated.

17.Skill development:

Efforts are made by the institute/ teachers to inculcate soft skills, life skills and employability skills among the students to make them ready for the world of work. Students seminar organized by all the department frequently, by which soft skill like communicative skill and preparing the seminar material developed among the students. students participate in the teaching learning process. Besides this, seventeen certificate course organised by the different department for additional skill and knoweldge. Two days workshop on "Self Defense" was conduced by the Women cell of the college in collaboration with Paschim Medinipur District Sports Karate-Do Association during 25-26 November, 2022.

- ?nv?k?ik? - used in the general sense of (contemporary) Science, encompassing logic and philosophy
- tray? - used to refer to traditional knowledge, to the Vedas in particular
- v?rtt? - used to represent wealth creation (agriculture and commerce)
- da??an?ti - used to represent politics and public administration

The subject of Indian Knowledge System has gained special acceptance in today's Education system to improve the tremendous knowledge of Bharat.

Kharagpur College is a College located in a multi-lingual community. The College has multiple Language departments namely Bengali, Hindi, Sanskrit and English and all these departments offer full programs or courses in different programs which deal with India Languages, Culture, and Knowledge System among other topics.

Besides, Departments like Philosophy, History, Sociology, Political Science provide courses on Indian culture and value systems like 'Indian Ethics', 'Teachings of Srimad Bhagabad Gita', 'History and Culture of Bengal and Bharat', 'Polity Society and Culture in Contemporary India', Colonial Economy, Society and culture, Ancient Indian History, Culture and Archaeology', Contemporary Indian Philosophy etc.

Physical Education department has also promoting practice of Yoga and Bratachari among students to develop the Indian knowledge tradition in our College. The ultimate goal of a Bratachari is the attainment of the ideal of the complete man by attaining perfection in self-development in all spheres of life- physical, mental, moral and social.

Various awareness programs are developed in the College such as Indian value system organized by various departments of the College as well as NSS and NCC units from time to time through Seminars, Webinars, certificate course, Special talks etc.

Part B

CURRICULAR ASPECTS

1.1 - Curricular Planning and Implementation

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

The institution incorporates a planned and well-documented method to ensure proper and effective delivery of the curriculum. In order to implement the curriculum of the UG and PG syllabi effectively, as framed by the affiliating university i.e., Vidyasagar University, the teachers and management devise an action plan in the beginning of the session through different academic sub-committees. The routine committee prepares the master routine in consultation with the HODs, and circulates to the departments for preparation and circulation of departmental routines. Routines are made after consideration of the guidelines of the University syllabus and opinion of the academic subcommittee. Provision of tutorial classes and classes for slow and advanced learners are also made. Syllabus distribution is done in the departmental meeting. All the teachers prepare their teaching plan before the commencement of classes so that curriculum delivery can be completed in time. Special lecture by the faculties of other colleges are also planned. Due to shortage of teachers in few

subjects, faculty of other colleges are also engaged. All the departments conduct two internal assessments for each paper as a part of the university prescribed examination pattern. At the end of each semester, Vidyasagar University conducts end-semester examination. For the session 2022-23, the university as well as the college functioned on offline mode as the institution reverted to classroom teaching. The college functioned according to its usual method of action with the pandemic situation being over.

The academic calendar which is prepared at the beginning of each session, chalks out the framework and probable course of action for each session. The tentative dates of internal assessments are mentioned in the academic calendar. Based on this academic calendar and the university notifications, departments prepare the schedule of Internal Assessments of each course. The departments also notify the date and time of assessments to the students. All the departments conduct internal assessments for each paper as a part of the university prescribed examination pattern. This is a continuous process which helps the institution to monitor student progress and ensure an effective delivery of the curriculum. After the conduction of the tests, feedbacks are shared with the students in the form of general discussion. The Internal Assessments are significant as these hold weightage in the end semester results under the university evaluation framework. Each department maintains proper documentation of the evaluative internal assessment conducted during each academic session. During session 2022-23, all the internal assessments were conducted thorough offline mode as both the parent university and the institution had switched back to normal functioning pattern with the pandemic situation being over.

1.3 - Curriculum Enrichment

1.3.1 - Institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability into the Curriculum

The Institution integrates converging issues relevant to Gender, Environment and Sustainability, Human Values and Professional Ethics to understand the problems and question them. Several undergraduate and postgraduate courses incorporate their course topics which cover gender issues, Environment ethics and Human values. To spread awareness among the girl students, a special paper on Women's Writing (For example in English literature, Sem-V, CC - 12, Philosophy, DSE - 2, Political Science- semester 1, CC - 1) is taught in classes to spread knowledge of women's rights, patriarchal oppression, etc. Environmental Studies is a part of Curriculum for all the 1st year UG students where students are made aware of various factors and issues pertaining to environment. They prepare projects on several burning issues concerning environment. English PG has courses on tribal, folk and Dalit literature, Gender studies and awareness about the environment and the Anthropocene (green awareness) which

inculcates caste awareness among students and make them familiar with issues pertaining to gender and the environment. Students prepare projects on the same, attend workshops covering those issues which sensitize them on the marginalized and sub-altern sections of the societal structure.

Study materials prepared by the teachers are uploaded in the departmental pages of the college website, so that any student can learn at her/his suitable time and scope which benefits the slow learners significantly. Special classes are also arranged for advanced learners. Advanced learners are always encouraged to choose advanced level topics for their presentation using PowerPoint presentation and computer simulation in the Students' Seminars organized by the departments. Advanced learners are encouraged and assisted by the departmental teachers to appear in national level exams and entrance tests (like JAM, JEST, CUCET etc.) for admission to prestigious institutions like IITs, JNU, BHU, AMU, JMIU, University of Hyderabad and many other institutions for higher studies like masters or integrated research etc.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Apart from classroom lectures, Kharagpur College tries to enhance the learning experience of students by adopting different students-centric methods of learning like experiential learning, participative learning and problem-solving methodologies both inside and outside the classroom.

The experiential learning strategies include open ended lab work, field works and projects. Experiential learning is encouraged through field surveys and interviews conducted by the Departments of Geography, English, Bengali, Zoology, Botany and Economics. This enables students to gain practical knowledge of what they learn in the classroom.

The participative learning is encouraged through students' seminars on relevant topics, field visits, group discussions, debates, Quiz contests. Projects, brain-storming sessions. IQAC, NSS unit, Cultural Sub-Committee organise seminars and debates where students from different disciplines participate. Problem solving ability of the students are enhanced by conducting project works by several Departments. Apart from formal classes, the teachers solve the queries of the students through assignments, discussions, and solve problem through personal communications etc. Departments of different disciplines give Special attentions to slow and advance learners while conducting classes and also

outside the class as well. Questions of national level examinations like JAM, JEST, NET, SET, CUETPG etc. are discussed in classes.

Kharagpur College has a transparent and continuous internal assessment system. Internal Assessment is mandatory as per the regulation of Vidyasagar University. The result of Internal Assessment(s) constitutes a part of the final score of each paper. Of a 75 marks paper, 10 marks are allotted for Internal Assessment. A part of marks in each paper is awarded through internally arranged Internal Assessment examination system and the rest is awarded by the University. Preservation of the records of the internal assessments is mandatory and the evaluated answer scripts are preserved by the Departments. In case of internally arranged class tests, evaluated answer scripts are often shown to the students so that they can find their mistakes from the checked answers and can point out mistake (if any) in evaluation. Viva-voce is also carried out with utmost transparency. In addition to class tests, Departments conduct students' seminars for internal assessment. If students' seminars are used as internal assessments, marking on the presentation of the students are done by a number of teachers and average result is taken.

As per UGC regulations, Kharagpur College has already constituted a Grievance Redressal Cell. Students can approach the respective heads of the Departments anytime with their grievances / queries regarding evaluation of their answer scripts or any related issues. Students can send their grievances regarding internal assessment through the respective Departmental email ids and as well as by submitting online grievance form which is available in the college webpage. If at any point of time during the course, a student finds himself /herself not happy with the evaluation of his/her answer script, he/she is free to relate all her grievances to the Head of the concerned Department. Now if the accusation is found justified by the Head of the Department, then H.O.D informs the concerned teacher. Again, if the complaint is against the Head of the Department, then it can be forwarded to the Grievance Redressal Cell which takes the necessary steps immediately. Complaint Box for students are placed at different places in the College campus. This cell redresses the grievances within 15 days.

Kharagpur College has an Entrepreneur Development Cell consisting of entrepreneurs, members from different local industries,

District Chamber of Commerce & Industries and a few teacher members. The cell periodically motivates the students of the college towards self-employment by interactions and visiting processes of industry. To further extend the opportunities to the students, Kharagpur College has created a link with the EDC of IIT Kharagpur and MSME.

The college intends to incubate young talents beyond their conventional studies. Students are encouraged to explore their talents in paintings, toy making, handicrafts, preparing delicious dishes etc through several competitions, exhibitions, Campus Bazar etc. The college authority has started the practice of purchasing selected items from the campus bazar, which are used as gifts to special guests & resource persons coming to the college. This practice has created huge response among the students. So far, two campus Bazar organised by the Kharagpur College in collaboration with the MGNCRE on 21.03.2023 & 15.05.2023.

College has an environment for inspiring the faculties and students to carry out innovative activities. There are some results; e.g.; a novel method devoid of H₂S gas has been developed to identify metal ions in the mixture by the Chemistry department. For practical H₂S scheme is used worldwide, in which H₂S is a major reagent. Our scheme creates much less pollution but much easier and faster. The work has been accepted for publication in the Journal of Chemical Education.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

The institution offers 19 undergraduate programmes (16 Honours and 3 General) and 3 post-graduate programmes in three shifts (Morning, Day and Evening). The total student strength including UG and PG programmes in academic session 2022-23 was 3952. B.A. General programme is held in the morning shift, while those of B.A. Honours and B.Sc. Honours & General programmes are held in the day shift. However, B.Com. Honours and General programmes are conducted in the evening shift. Out of the total 50 classrooms, 18 are ICT enabled. Of the ICT enabled classrooms 08 smart classrooms are equipped with modern interactive flat touch panels. All departments have laptops/desktops and printers. The institution has 01 auditorium, 06 seminar rooms and 08 computer laboratories. There are total 25 science laboratories. Presently, there are total 224computers available for academic purpose.

Central library has a collection of Central library has a collection of 39776 books along with N-LIST annual membership subscription for accessing online e-books and e-journals. All departments have their own seminar libraries. Students of Bengali, English, History and Physics also have access to use their departmental libraries.

Various cultural activities are performed during observation of college foundation day, Republic Day, Independence Day, Teachers' Day, Rabindra Jayanti, Freshers' welcome etc. All departments publish wall magazines.

There is an open stage (Mukta Mancha) for different cultural activities. The entire campus is under 37 IP CC camera surveillance for 24 hours. There are 11 water purifiers and cooler cum purifiers in the campus. A 20 KVA Solar Grid Power Plant is installed in the college. The college owns three green power generators. The college has a canteen cum snacks bar where healthy foods are supplied to the staff & students. Separate parking shed for staff & students are also there. There are ramps and toilets for differently able people in the college.

For purchasing and maintaining academic facilities like laboratory materials, equipment, computers, scanners etc, departmental committees apply to principal online and offline furnishing proper justification and approximate budget, that is forwarded to the Purchase Sub Committee, which then ensures purchase of the materials maintaining tender rules of Govt. of West Bengal. Regular maintenance of the laboratory equipment is supervised by the respective HODs with the assistance of the laboratory staff. Building Sub-committee constituted by a State Govt. nominee and an Assistant Engineer, Paschim Medinipur Zilla Parishad, along with

teaching and non-teaching staff, formulates proposal for creation of physical facilities, renovation of existing facilities and maintenance of existing infrastructure. Academic Sub-Committee comprising all HODs looks after preparation, supervising and necessary upgradation of class routine, remedial and tutorial classes. Library Sub-Committee, headed by the librarian maintains and upgrades library facilities. The student concession subcommittee of the college takes care of the issues related to scholarship, and concession of tuition fees etc. to the poor and meritorious students. 6.4.3 - Institutional strategies for mobilization of funds and the optimal utilization of resources

Being a Government Aided institution, the source of funds is from the Higher Education Department of Government of West Bengal, UGC, and Students fees. A large part of the salary component is received from the Government of West Bengal and remaining part of the salary component is paid from the fees collected from the students. Funds were also received from the RUSA Scheme and from the research projects. Departments, Central Library and different units/cells apply to the principal for the purchase/ maintenance of equipment, books and journals, computers, contingencies, organizing events and other requirements stating proper justification and budget. The principal conducts meetings with the Departmental Heads/cells/units, Coordinator, IQAC, Secretary Teachers' Council and Librarian to finalize the allotment of funds. Subsequently, the "Central Purchase and Tender Committee" performs all processes such as inviting tender/quotations, preparing comparative statement and selection of vendors strictly following the Government Guidelines in all purchases. On receipt

of the respective items, concerned department/cell/unit verifies the same. While purchasing an equipment, it is always ensured that the installation charges and maintenance charges (within warranty period) are provided by the vendors, which delivers the equipment. The Internal Quality Assurance Cell continuously reviews the teaching learning process of the college with the help of Academic Subcommittee, Teachers' Council, Departmental meetings and Board of Studies of the various PG departments. Departments regularly monitor the progress of the learners via several assignments from time to time to identify the slow and advanced learners. Periodical Tests for assessing the progress are held at regular intervals in consonance with the Academic Calendar. The IQAC has arranged for online feedback from different stakeholders like students, teachers, parents and alumni for the overall development of the College. During regular Mentor-Mentee meeting, teachers become aware about various issues of the students and discuss necessary suggestions to solve the issues also provides feedbacks for improvement of the results of the University examinations.

Again on 4th May 2023 Dr Sarbasree Bandyopadhyya Associate Professor Department of History, Pingla Mahavidyalay demonstrated how poverty, famine, unemployment kills humanity through screening two renowned films '22 se Shravana' and 'Ashani Sanket'.

Also, Professor. Biswajit Koyohri, Department of History, Kharagpur College discussed on the evolution of women's position in the history of film during last six decades. Altogether 150 students participated spontaneously in these two film shows.

Solid waste management:

Coloured dustbins are used to collect the solid waste in segregated form. This is then subsequently collected by the local Municipality from the college campus.

- The Green-colored dustbins are used for wet and biodegradable wastes.
- Blue dustbins are used for disposal of plastic wrappers and non-biodegradable wastes.
- Yellow dustbins are meant for papers and glass bottles.

The entire campus is a "plastic free zone" and the institution sincerely puts efforts to maintain the same. Portion of the Biodegradable waste is used as manure for the plants in the garden.

Liquid waste management:

Liquid chemical waste products produced from the laboratories are treated before disposal. As a routine practice, chemical wastes are segregated as acids and bases.

1.1 - Curricular Planning and Implementation

1.1.1 - The Institution ensures effective curriculum delivery through a well planned and documented process

The institution incorporates a planned and well-documented method to ensure proper and effective delivery of the curriculum. In order to implement the curriculum of the UG and PG syllabi effectively, as framed by the affiliating university i.e., Vidyasagar University, the teachers and management devise an action plan in the beginning of the session through different academic sub-committees. The routine committee prepares the master routine in consultation with the HODs, and circulates to the departments for preparation and circulation of departmental routines. Routines are made after consideration of the guidelines of the University syllabus and opinion of the academic subcommittee. Provision of tutorial classes and classes for slow and advanced learners are also made. Syllabus distribution is done in the departmental meeting. All the teachers prepare their teaching plan before the commencement of classes so that curriculum delivery can be completed in time. Special lecture by the faculties of other colleges are also planned. Due to shortage of teachers in few subjects, faculty of other colleges are also engaged. All the departments conduct two internal assessments for each paper as a part of the university prescribed examination pattern. At the end of each semester, Vidyasagar University conducts end-semester examination. For the session 2022-23, the university as well as the college functioned on offline mode as the institution reverted to classroom teaching. The college functioned according to its usual method of action with the pandemic situation being over.

The Internal Assessments are significant as these hold weightage in the end semester results under the university evaluation framework. Each department maintains proper documentation of the evaluative internal assessment conducted during each academic session. During session 2022-23, all the internal assessments were conducted thorough offline mode as both the parent university and the institution had switched back to normal functioning pattern with the pandemic situation being over.

Several undergraduate and postgraduate courses incorporate their course topics which cover gender issues, Environment ethics and Human values. To spread awareness among the girl students, a special paper on Women's Writing (For example in English literature, Sem-V, CC - 12, Philosophy, DSE - 2, Political Science- semester 1, CC - 1) is taught in classes to spread knowledge of women's rights, patriarchal oppression, etc. Environmental Studies is a part of Curriculum for all the 1st year UG students where students are made aware of various factors and issues pertaining to environment. They prepare projects on several burning issues concerning environment. English PG has courses on tribal, folk and Dalit literature, Gender studies and awareness about the environment and the Anthropocene (green awareness) which inculcates caste awareness among students and make them familiar with issues pertaining to gender and the environment. Students prepare projects on the same, attend workshops covering those issues which sensitize them on the marginalized and sub-altern sections of the societal structure.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Apart from classroom lectures, Kharagpur College tries to enhance the learning experience of students by adopting different students-centric methods of learning like experiential learning, participative learning and problem-solving methodologies both inside and outside the classroom.

The experiential learning strategies include open ended lab work, field works and projects. Experiential learning is encouraged through field surveys and interviews conducted by the Departments of Geography, English, Bengali, Zoology, Botany and Economics. This enables students to gain practical knowledge of what they learn in the classroom.

The participative learning is encouraged through students' seminars on relevant topics, field visits, group discussions, debates, Quiz contests. Projects, brain-storming sessions. IQAC, NSS unit, Cultural Sub-Committee organise seminars and debates where students from different disciplines participate. Problem solving ability of the students are enhanced by conducting project works by several Departments. Apart from formal classes, the teachers solve the queries of the students through assignments, discussions, and solve problem through personal communications etc. Departments of different disciplines give special attentions to slow and advance learners while conducting classes and also outside the class as well. Questions of national level examinations like JAM, JEST, NET, SET, CUETPG etc. are discussed in classes.

Kharagpur College has a transparent and continuous internal assessment system. Internal Assessment is mandatory as per the regulation of Vidyasagar University. The result of Internal Assessment(s) constitutes a part of the final score of each paper. Of a 75 marks paper, 10 marks are allotted for Internal Assessment. A part of marks in each paper is awarded through internally arranged Internal Assessment examination system and the rest is awarded by the University. Preservation of the records of the internal assessments is mandatory and the evaluated answer scripts are preserved by the Departments. In case of internally arranged class tests, evaluated answer scripts are often shown to the students so that they can find their mistakes from the checked answers and can point out mistake (if any) in evaluation. Viva-voce is also carried out with utmost transparency. In addition to class tests, Departments conduct students' seminars for internal assessment. If students' seminars are used as internal assessments, marking on the presentation of the students are done by a number of teachers and average result is taken.

If at any point of time during the course, a student finds himself / herself not happy with the evaluation of his/her answer script, he/she is free to relate all her grievances to the Head of the concerned Department. Now if the accusation is found

justified by the Head of the Department, then H.O.D informs the concerned teacher. Again, if the complaint is against the Head of the Department, then it can be forwarded to the Grievance Redressal Cell which takes the necessary steps immediately. Kharagpur College has an Entrepreneur Development Cell consisting of entrepreneurs, members from different local industries, District Chamber of Commerce & Industries and a few teacher members. The cell periodically motivates the students of the college towards self-employment by interactions and visiting processes of industry. To further extend the opportunities to the students, Kharagpur College has created a link with the EDC of IIT Kharagpur and MSME.

The college intends to incubate young talents beyond their conventional studies. Students are encouraged to explore their talents in paintings, toy making, handicrafts, preparing delicious dishes etc through several competitions, exhibitions, Campus Bazar etc. The college authority has started the practice

of purchasing selected items from the campus bazar, which are used as gifts to special guests & resource persons coming to the college. This practice has created huge response among the students. So far, two campus Bazar organised by the Kharagpur College in collaboration with the MGNCRE on 21.03.2023 & 15.05.2023.

College has an environment for inspiring the faculties and students to carry out innovative activities. There are some results; e.g.; a novel method devoid of H₂S gas has been developed to identify metal ions in the mixture by the Chemistry department. For practical H₂S scheme is used worldwide, in which H₂S is a major reagent. Our scheme creates much less pollution but much easier and faster. The work has been accepted for publication in the Journal of Chemical Education.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

The institution offers 19 undergraduate programmes (16 Honours and 3 General) and 3 post-graduate programmes in three shifts (Morning, Day and Evening). The total student strength including UG and PG programmes in academic session 2022-23 was 3952. B.A. General programme is held in the morning shift, while those of B.A. Honours and B.Sc. Honours & General programmes are held in the day shift. However, B.Com. Honours and General programmes are conducted in the evening shift. Out of the total 50 classrooms, 18 are ICT enabled. Of the ICT enabled classrooms 08 smart classrooms are equipped with modern interactive flat touch panels. All departments have laptops/desktops and printers. The institution has 01 auditorium, 06 seminar rooms and 08 computer laboratories. There are total 25 science laboratories. Presently, there are total 224computers available for academic purpose.

Central library has a collection of Central library has a collection of 39776 books along with N-LIST annual membership subscription for accessing online e-books and e-journals. All departments have their own seminar libraries. Students of Bengali, English, History and Physics also have access to use their departmental libraries.

There is an open stage (Mukta Mancha) for different cultural activities. The entire campus is under 37 IP CC camera surveillance for 24 hours. There are 11 water purifiers and cooler cum purifiers in the campus. A 20 KVA Solar Grid Power Plant is installed in the college. The college owns three green power generators. The college has a canteen cum snacks bar where healthy foods are supplied to the staff & students. Separate parking shed for staff & students are also there. There are ramps and toilets for differently able people in the college.

The college practises its decentralised policies for maintaining and utilizing physical, academic and support facilities through formation and functioning of different sub committees comprising teachers, non-teaching staff and students' representative. The policies through approval of Finance Sub-Committee are approved by the Governing Body of the

College. For purchasing and maintaining academic facilities like laboratory materials, equipment, computers, scanners etc, departmental committees apply to principal online and offline furnishing proper justification and approximate budget, that is forwarded to the Purchase Sub Committee, which then ensures purchase of the materials maintaining tender rules of Govt. of West Bengal. Regular maintenance of the laboratory equipment is supervised by the respective HODs with the assistance of the laboratory staff. Building Sub-committee constituted by a State Govt. nominee and an Assistant Engineer, Paschim Medinipur Zilla Parishad, along with teaching and non-teaching staff, formulates proposal for creation of physical facilities, renovation of existing facilities and maintenance of existing infrastructure. Academic Sub-Committee comprising all HODs looks after preparation, supervising and necessary upgradation of class routine, remedial and tutorial classes. Library Sub-Committee, headed by the librarian maintains and upgrades library facilities. The student concession subcommittee of the college takes care of the issues related to scholarship, and concession of tuition fees etc. to the poor and meritorious students. The sports and Games subcommittee looks after college playground, indoor sports hall and swimming pool. And the committee conducts different events throughout the year.

Being a Government-aided institution, the college receives grant for salary and some special grants for development from the Government of West Bengal and RUSA. The college also collects nominal fees from the student for development and smooth operation purpose. There is a Finance Sub-Committee which monitors the appropriate use of available fund of the college. One member from the teaching staff is appointed as Bursar of the college for 2 (two) years to look after the financial aspects of the college. The decisions of the Finance Sub-Committee, Purchase Sub-Committee and Bursar to be approved by the Governing Body. The college accounts are jointly operated by the Principal (who is also the Secretary of the Governing Body) and one external member of the Governing Body. Annual audit of the college finances is made on a regular basis. All

processes relating to the financial audit of the college for the financial year 2022-23 is completed, and the same is likely to be audited by an authorized auditor of Government of West Bengal very soon.

6.4.3 - Institutional strategies for mobilization of funds and the optimal utilization of resources

Being a Government Aided institution, the source of funds is from the Higher Education Department of Government of West Bengal, UGC, and Students fees. A large part of the salary component is received from the Government of West Bengal and remaining part of the salary component is paid from the fees collected from the students. Funds were also received from the RUSA Scheme and from the research projects. Departments, Central Library and different units/cells apply to the principal for the purchase/ maintenance of equipment, books and journals, computers, contingencies, organizing events and other requirements stating proper justification and budget. The principal conducts meetings with the Departmental

Heads/cells/units, Coordinator, IQAC, Secretary Teachers' Council and Librarian to finalize the allotment of funds. Subsequently, the "Central Purchase and Tender Committee" performs all processes such as inviting tender/quotations, preparing comparative statement and selection of vendors strictly following the Government Guidelines in all purchases. On receipt of the respective items, concerned department/cell/unit verifies the same. While purchasing an equipment, it is always ensured that the installation charges and maintenance charges (within warranty period) are provided by the vendors, which delivers the equipment. Such clause is inserted in the work order/purchase order of the equipment.

Departments regularly monitor the progress of the learners via several assignments from time to time to identify the slow and advanced learners. Periodical Tests for assessing the progress are held at regular intervals in consonance with the Academic Calendar. The IQAC has arranged for online feedback from different stakeholders like students, teachers, parents and alumni for the overall development of the College. During regular Mentor-Mentee meeting, teachers become aware about various issues of the students and discuss necessary suggestions to solve the issues also provides feedbacks for improvement of the results of the University examinations.

7.1.1 - Measures initiated by the Institution for the promotion of gender equity during the year

Gender equality means equal rights, responsibilities and opportunities for all genders. Through gender sensitization we

must try to create environment of working men and women together with a personal safety and dignity.

Women Cell, Kharagpur College, organized a two-day workshop (25-26 November 2022) on Self-defense (200 participants) in collaboration with All India Seshinkai Shito-RWU Karate-Do Federation to give lessons on the self-protection techniques for the girls in adverse situation.

Film show is considered as a powerful weapon on the question of creating awareness about gender issues. To celebrate International Women's Day Prof Soumyabrta Sil showed us three short films respectively-"Devi", "Juice", and "Pencil" Box on 26th April, 2023. Overall the films deal with the questions surrounding gender, problematizes them, initiates questions by probing into spheres which the society tends to overlook.

Kanyashree and scholarship for single girlchild are also arranged for financial supports to the girl student. Internal complaint committee is also active for gender equity.

Again on 4th May 2023 Dr Sarbasree Bandyopadhyia Associate Professor Department of History, Pingla Mahavidyalay demonstrated how poverty, famine, unemployment kills humanity through screening two renowned films '22 se Shravana' and 'Ashani Sanket'.

Also, Professor. Biswajit Koyohri, Department of History, Kharagpur College discussed on the evolution of women's position in the history of film during last six decades. Altogether 150 students participated spontaneously in these two film shows.
