MEMORANDUM OF UNDERSTANDING (MoU)

This MoU is being executed between Kharagpur College, 983P+P72, Kharagpur City Rd, Inda, Kharagpur, West Bengal 721305 affiliated to The Vidyasagar University & BANDHAN - KONNAGAR, a Society, Registered under the West Bengal Societies Registration Act, 1961, having its registered office at 99 H/2 Haran Chandra Banerjee Lane, Konnagar, Hooghly, Pin No: 712235 and corporate office at Bandhan Konnagar, Shrachi EK Tower, 7th Floor, 12 Street number 692, Plot No: IID/30, Action area IID, New Town, West Bengal 700161.

I. Deliverables of Bandhan Konnagar:

- 1. To initiate the development of the underprivileged youth for providing skill development training for making them job ready in the sectors of ITES-BPO, MFI, Sales Management and Warehouse (Logistics) Executive.
- Description of the Job-linked programme.

§ II. Eligibility Criteria for getting certified to grab a job:

Minimum Class XII Passed out. Age Limit: 18 Years to 28 Years and Minimum 80% of the student's attendance in the entire duration of Three(03)Months Training program and have to secure 70% marks in the conducted Examination.

I. Deliverables of Kharagpur College:

- 1. Cooperation to conduct programs on mutually decided date, time and place.
- 2. Access to the students at Kharagpur College to motivate and interact with them relating to job opportunities and relevant trainings.
- 3. Provide necessary infrastructure free of cost to conduct interactive sessions with the students at Kharagpur College.

IV. Financial arrangements:

- a. No financial commitment is required / involved with Kharagpur College to execute the terms and conditions of the MoU.
- b. However, the Bandhan Konnagar shall charge maximum of Rs. 4000/*- as course fees (Onetime Payment) for training program from the students.
- * Subject to change

V. Terms and conditions:

- It is mutually understood and agreed by and between Kharagpur College and Bandhan Konnagar, that the MoU will remain effective for 3 (Three) years. The MoU may be extended or revised after every 3 (Three) years on mutual discussion between the two Institutes viz. Kharagpur College, and Bandhan Konnagar. Awareness and Seminars/Mobilisation would be conducted as and when required, either at Kharagpur College, Kharagpur or Bandhan Konnagaror both places, on the basis of mutual consent. The MoU may be extended or revised after every 3 (Three) years on mutual discussion between the two Institutes viz. Kharagpur College, and Bandhan Konnagar.
- This MoU shall be governed and construed according to the laws of the country for each participating party. Any dispute will jointly be resolved involving the Principal of Kharagpur College and the Bandhan Konnagar, Shrachi EK Tower, 7th Floor, 12 Street number 692, Plot No: IID/30, Action area IID, New Town, West Bengal 700161, in a spirit of independence, mutual respect, and shared responsibility.
- The MoU may be terminated by either party after giving a notice of six months
 (180 days) provided that this clause will be operative only if either party
 violates the terms of MoU or if the parties feel that no useful purpose would be
 served by further continuing it either due to change in circumstances or
 change in constituting parties.





VI.Confidentiality:

Both the parties shall maintain in confidence and safeguard all information that the each party may come to know as a result of this Agreement.

XI.Entire Agreement - Execution and Modification

This Agreement wholly cancels, terminates and supersedes any and all previous agreements, negotiations, commitments and writings between the Parties in connection with the subject matter of this Agreement.
